



KEY FINDINGS in LA PAZ, MEXICO

Emotional Violence	In a community where Facebook and WhatsApp dominate communication across all generations and where domestic violence lacks judicial oversight, these social media platforms are used to perpetrate emotional violence without consequence.
Psychological Impact	Victims in La Paz experience severe psychological distress, including anxiety and suicidality, exacerbated by the small-community nature of abuse on social media platforms like Facebook.
Academic Outcomes	Female college students in La Paz, already facing cultural and economic challenges, are further disadvantaged by the impact of social media-facilitated abuse leading to higher college dropout rates among victims.
Privacy and Security	In La Paz, where legal responses to domestic violence are limited, the challenges of addressing digital emotional abuse are even more pronounced. This creates a significant barrier to obtaining justice and protection for victims.
Adult Victims	The study shifts focus from children to adult college students in La Paz, revealing the pervasive impact of social media-facilitated emotional abuse on this underexplored demographic. of

emotional manipulation and control.

CASE STUDIES FROM LA PAZ, BAJA CALIFORNIA SUR

- Maria's Story: Public humiliation on Facebook led to heightened anxiety and depression, affecting her academic performance.
- Isabella's Story: Emotional manipulation and betrayal through social media resulted in her dropping out of college and returning to her home country for safety.
- Sofia's Story: Emotional abuse by a man posing as a university director led to suicidality and academic disengagement.

RECENT RESEARCH ON SOCIAL MEDIA HARM

In recent research, numerous reports have highlighted the increasing prevalence of emotional abuse facilitated by social media.

Studies have shown that social media platforms contribute to a rise in mental health issues among users, particularly young adults and women (McKinsey & Co, 2022).

Recent studies highlight the significant impact of social media usage on educational outcomes, particularly focusing on the relationship between time spent on social media and poorer academic performance (Bedua et al., 2021).

PROPOSED SOLUTIONS

01. AI INTEGRATION FOR IDENTIFYING FALSE PERSONAS

Implementation: Develop AI tools that can analyze user profiles, crossreference data across multiple platforms, and identify inconsistencies or signs of false personas. This AI feature could be integrated into social media platforms as an add-on, assisting users in recognizing potential deceitful behavior.

Role of Experts: Collaborate with subject matter experts in emotional abuse and digital behavior to refine AI algorithms, ensuring they capture the nuanced signs of emotional manipulation. This collaboration will help in creating more effective tools that can assist victims in identifying red flags.

Example: Similar tools are already used in fraud detection and cybersecurity; adapting these for personal safety and emotional abuse detection is a realistic step forward.

02. ENHANCED REPORTING MECHANISMS

- Develop Al-driven tools that prioritize and filter reports based on severity and patterns of behavior, ensuring serious cases receive prompt attention.
- Educate users on how to effectively report abuse without overwhelming the system.

03. BROADER SOCIAL IMPLICATIONS

- Implement educational programs within the platforms to raise awareness about the signs of digital manipulation and emotional abuse.
- Partner with social media companies, educational institutions, and NGOs to deliver these programs.
